**PAPERS REQUIRED FOR OPENING FOREIGN CURRENCY ACCOUNT.**

- 1) Opening forms (Application, Nomination if any, Declaration, signature Card and KYC profile Form) duly filled in and Signed.
  - 2) Original passport and its photocopy of First Seven page in duplicate (two sets).
  - 3) Three passport size photograph of the Account holder duly attested by him
  - 4) Three passport size photograph of the nominee duly attested by A/c holder.
  - 5) 'A' marked for A/c holder's signature and 'N' marked for nominee's signature.
  - 6) In case the intending persons desire to open the account from abroad the necessary papers excluding original passport as described under column 1, 2, to be sent duly attested by the authorised officials of Bangladesh embassy working there.
  - 7) Please note that only one foreign currency A/c either in US dollar or pound Sterling or Euro may be opened by the prospective A/c holder.
- Please also note to sign the forms in exactly the same manner as your signature in the passport. If different forms of signature is desired by the opener it may be accepted with conditions that on the left bottom of opening form signature as in the passport has to be obtained in the Bank counter.
